RESOLUTION NO. 2018-001

**RESOLUTION DESIGNATING A PLAN FOR TRANSITIONING FROM
MARCH TO NOVEMBER TOWNSHIP GENERAL ELECTIONS**

WHEREAS, Minn. Stat. § 205.075 provides townships the option to designate the first Tuesday after the first Monday in November of either the even-numbered or the odd-numbered year as the date of the Township general election; and

WHEREAS, the Town Board had previously determined at its December 5, 2017 meeting by adoption of Resolution No. 2017-23 that changing the Township's general election date from March to November for even-numbered years serves the public's interest by aligning the Township's election with the other November elections; and

WHEREAS, Minn. Stat. § 205.075 requires that the Township develop and adopt a plan to lengthen the terms of office to provide an orderly transition to the November election schedule; and

WHEREAS, certain members of the Town Board who wished to participate in the creating of the required transition plan were unavailable to attend the December 5, 2017 meeting so the Town Board voted to table adoption of the required transition plan to its January meeting.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the following plan shall be used to provide an orderly transition to the November election schedule by lengthening the terms of office:

1. The supervisor position that expires in March of 2018 shall be designated "Supervisor Position Seat 1" and the person serving in the position will serve until the first business day in January of 2023; and
2. The supervisor position that expires in March of 2019 shall be designated "Supervisor Position Seat 2" and shall be extended so as to be on the ballot in November of 2020 and the person serving in the position will serve until the first business day in January of 2021; and
3. The supervisor position that expires in March of 2020 shall be designated "Supervisor Position Seat 3" and shall be extended so as to be on the ballot in November of 2020 and the person serving in the position will serve until the first business day in January of 2021; and
4. The supervisor position that expires in March of 2020 shall be designated "Supervisor Position Seat 4" and shall be extended so as to be on the ballot in November of 2020

and the person serving in the position will serve until the first business day in January of 2021; and

5. The supervisor position that expires in March of 2018 shall be designated “Supervisor Position Seat 5” and the person serving in the position will serve until the first business day in January of 2023; and
6. The town treasurer position that expires in March of 2019 shall be extended so as to be on the ballot in November of 2020 and the person serving in the position will serve until the first business day in January of 2021.
